**RULES AND REGULATIONS  
FOR TROY COMMUNITY CENTER TEEN ROOM**

This agreement is entered into between Troy Parks and Recreation, Member and Parent/Legal Guardian, as stated above.

Member hereby agrees to abide by all of the rules and policies as designated by the staff and members of the community center, as stated below:

1. Member will be responsible to notify parent/legal guardian of their daily plans for after school or summer activities and arrange for their own transportation home by the time the Community Center is scheduled to close.
2. Members must be resident of Troy and currently in grades 6 – 12.
3. Member will be responsible for equipment checked out and will return equipment in the same condition at the end of the day prior to leaving the Community Center. *If not, the Member and/or the Member's parents or guardian shall be responsible for paying full replacement costs.*
4. Member agrees to abide by all Community Center and Teen Room rules.
5. Member may bring in one non-resident guest per day. Non-resident guests must have parent/legal guardian complete membership and rules form prior to entry
6. Member must submit picture identification to staff, sign in and have hand stamped prior to entering room.
7. Appropriate language will be used at the Community Center at all times.
8. Common sense rules will be in place and are to be followed by Member at all times.
9. No inappropriate behavior.
10. A time limit of 30 minutes will be enforced for games and CD player when other patrons are waiting.
11. Member must report food/drink spills immediately.
12. Prohibited items include: open flames, roller blades/skateboards, and use of tape or tacks on walls.
13. **NO** pushing, shoving, fighting, or throwing objects.
14. **NO** teasing or bullying
15. **NO** yelling. Talk in a normal tone of voice.
16. **ABSOLUTELY NO** smoking, drinking alcohol, use of any illegal drugs, or weapons.
17. DVD's and videos will be limited to PG13 rating and below.
18. *Violations of any of the rules at the Community Center may jeopardize your privileges in the program and use of the Community Center. The Member indicates by his/her signature on this document that they have read the rules and regulations contained herein and understands them.*
